

- 5. The school to renew mandatory certificates from time to time.
- 6. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.

The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed on the basis of land holding for any school.

The number of sections and students shall be restricted as per the actual facilities in the school.

Important Notes: 1. The total number of sections of the school shall be restricted to 10 and numbers of students are restricted 32 in the 4 sections which are less than 500 ft. Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws for available classrooms of size 500ft.

- 2. The School should provide the EPF facility to the staff members and submit the documentary evidence within 03 months in the compliance.
- 3. The school has a lift up to 2nd floor only. The school shall extend the same to 3rd floor or construct a ramp for CWSN to access all the floors of the school as per norms of RPwD Act and guidelines issued by the Board and submit compliance on SARAS within 3 months,
- 4. The school has created CWSN toilets, but they are not as per norms. The cubicles dont have enough space for wheelchair/walker to navigate. The school has tried to make up for the deficiencies by placing temporary wooden wedges as ramps on un even surfaces in washrooms, which is dangerous for safety of students and unacceptable. All the urinals in boys washrooms are on raised platforms, inaccessible to CWSN. The school shall construct separate toilets for CWSN on every floor as per the norms prescribed by RPwD Act and guidelines issued by the Board and submit compliance within 3 months on SARAS portal.
- 5. The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.
- 6. The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time
- 7. The school shall conduct mandatory training of its teachers with CoE Bengaluru within 3 months and submit compliance on SARAS portal.
